2. THIS MESSAGE APPLIES TO RC (TPU, M-DAY, AGR, AND MILITARY TECHNICIAN (DUAL STATUS) SOLDIERS SERVING ON ACTIVE DUTY IN AFGHANISTAN, IRAQ, AND KUWAIT ONLY. REFERENCE G ABOVE IS SUPERSEDED BY THIS MESSAGE.

3. EFFECTIVE JANUARY 1, 2007 THROUGH DECEMBER 31, 2007 UNLESS SOONER SUPERSEDED, THIS MESSAGE AUTHORIZES SOLDIERS QUALIFIED TO REENLIST UNDER PROVISIONS (UP) AR 140-111, CHAPTER 2 (USAR) AND NGR 600-200, CHAPTER 7 (ARNG) TO RECEIVE BONUSES AUTHORIZED UNDER THE SELECTED RESERVE INCENTIVE PROGRAM IAW 37 U.S.C., SEC 308B OR SELECTIVE REENLISTMENT BONUS (SRB) (FOR AGR SOLDIERS) IAW 37 U.S.C. SEC 308.

4. UP 37 U.S.C. 308B OR 37 U.S.C. 308 SOLDIERS VOLUNTARILY REENLISTING OR EXTENDING WHILE IN AFGHANISTAN, IRAQ, OR KUWAIT IN SUPPORT OF OPERATION ENDURING FREEDOM OR OPERATION IRAQI FREEDOM ARE NOT REQUIRED TO SATISFY THE DESIGNATED SKILL OR UNIT REQUIREMENT REQUIRED UNDER 37 U.S.C. 308B (A)(2) OR (C)(1)(B) AND 37 U.S.C. 308 (A)(1)(B).
5. BONUS AMOUNTS WILL NOT EXCEED THE MAXIMUM AMOUNT AUTHORIZED BY THE CURRENT NGB AND USAR SRIP/SRB POLICY IN EFFECT ON THE DAY THE AGREEMENT IS EXECUTED AND SIGNED.
6. USAR RETENTION PERSONNEL WILL TYPE OR HAND WRITE ON THE REENLISTMENT BONUS WRITTEN AGREEMENT IN BLUE/BLACK INK WAIVER OF THE REQUIREMENTS OF SECTION III, PARA 3 IAW (USE DATE TIME GROUP OF THIS MESSAGE & SUBJECT) IN THE SPACE BELOW 3C. THE DA FORM 5261-2 WILL REPLACE THE AFOREMENTIONED WRITTEN AGREEMENT ONCE IT HAS BEEN RELEASED FOR USE BY THE ARMY PUBLISHING DIRECTORATE.
7. QUESTIONS REGARDING EXECUTION/IMPLEMENTATION OF THIS POLICY SHOULD BE DIRECTED TOWARDS THE APPROPRIATE RETENTION PERSONNEL WITHIN THE RESPECTIVE RESERVE COMPONENT.
