B. DESERT ABDU/TAN ONE PIECE FLIGHT SUIT - SUBDUED KHAKI, SHOULDER  
SLEEVE INSIGNIA AND SUBDUED SHOULDER SLEEVE INSIGNIA- FORMER WARTIME  
SERVICE, KHAKI NAMETAPE AND U.S. ARMY INSIGNIA

C. BELT, WEB WITH OPEN-FACED BLACK BUCKLE

D. OLIVE DRAB GREEN NAMETAPE AND U.S. ARMY INSIGNIAS
