SUBJECT: AR 670-1, 3 FEB 05, WEAR AND APPEARANCE OF ARMY UNIFORMS AND
INSIGNIA

1. THIS MESSAGE SERVES AS IMPLEMENTING INSTRUCTIONS FOR CHANGES TO THE
WEAR POLICY OUTLINED IN AR 670-1 REFERENCE ACQUISITION CORPS COLLAR
INSIGNIA AND REGIMENTAL DISTINCTIVE INSIGNIA (RDI) (ENLISTED SOLDIERS
ONLY).

2. THE FOLLOWING CHANGE IS ADDED TO AR 670-1: PARAGRAPH 28-10 (38)
ACQUISITION CORPS COLLAR INSIGNIA (ENLISTED PERSONNEL ONLY). THE
INSIGNIA IS A TRIPARTITE GOLD SCROLL INSCRIBED WITH "INNOVATION,
EXCELLENCE, AND DEDICATION" AND TWO GOLD CROSSED LAUREL BRANCHES WITH
AN EAGLES HEAD ON A 1-INCH DISK, IN GOLD-COLORED METAL.

3. ACQUISITION UNITS ORGANIZED UNDER STANDARD REQUIREMENT CODE 90 WILL
NOT RE-DESIGNATE FROM "SUPPORT" TO "ACQUISITION" DESIGNATION.

4. AS AN EXCEPTION TO POLICY OUTLINED IN AR 600-82, SOLDIERS AWARDED
MILITARY OCCUPATIONAL SPECIALTY 51C ARE AUTHORIZED WEAR OF A
REGIMENTAL DISTINCTIVE INSIGNIA. THE INSIGNIA IS A GOLD METAL AND
ENAMEL DEVICE 1 1/8 INCH IN HEIGHT CONSISTING OF A BLACK BACKGROUND
ENCLOSED BY A TRIPARTITE GOLD SCROLL INSCRIBED "INNOVATION,
EXCELLENCE, AND DEDICATION" IN RED AT TOP AND BY TWO GREEN CROSSED
LAUREL BRANCHES AT BOTTOM AND CHARGED WITH AN EAGLE'S HEAD EMBRACED BY
SWORDS IN PROPER COLORS THAT REST UPON THE LATIN WORDS; "PACTUM
EXCELLO" MEANING "CONTRACTING EXCELLENCE".
